C. Programs Committee Report

The October Programs Committee centered on Indiana's School Accountability Grade System. School Grades just came out from the state for the 16-17 school year, and we have already begun the 2017-18 and 2018-19 strategies. This year the Federal ESSA replaces the No Child Left Behind Act. With this change, comes other changes in the accountability program. Discussion followed.

D. High School Grades Committee Report

September marked the first meeting of the High School Grades Committee. Like I update you on the Programs Committee, I will also spend a little time each month talking about the proceedings of this committee. There are two teachers, two parents/patrons, two board members, the guidance department chair, the principal and myself on this committee. Our first meeting was spent going over a number of problems that we are encountering with our grade system, with our student information system in regards to grade calculations, and issues related to these items. A number of different things were put out by the committee, including a number of possible changes that need researching. This committee meets on the last Wednesday of each month and will have some recommendations to make to this board by the April meeting.

NEW BUSINESS

A. 2018-19 School Calendar Discussion

Time is flying by and October and November are the traditional months to set the school calendar for the next year, which would be 2018-19. We find ourselves in an interesting position this year. We have been told that legislation is coming that would prohibit the start of school until the last Monday of August. With the session not beginning until after Christmas that would put us very late in the process. I would like to put together two different calendars...one if legislation passes and one if it does not. Spring Break is the last full week of March in alignment with the other districts in the county. The year would culminate with graduation on Friday evening prior to Memorial Day at 7:30PM in the WRV gymnasium.

I have already held Formal Discussion with the Teachers' Association. The superintendents are meeting next week to discuss the possibility of all of us being on the same calendar. The final authority lies with the Board of Education, and so tonight I would like to get some input before making a formal recommendation at our November meeting. I am asking for some input at this time. Discussion followed.

B. Life Insurance Renewal - Principal

It is also time to renew our term group life insurance, our accidental death and dismemberment, and our child life insurance services. We are pleased to announce that there is no rate increase this year, which is outstanding. It is my recommendation to go with Principal Life Insurance for these services.
